RESOLUTION NO.

WHEREAS, Pursuant to La. R.S. art 33:9091.6, the Upper Hurstville Security District, a political subdivision of the state, was created by an election by the majority of the voters of the Upper Hurstville; and

Whereas, the aforementioned Act authorized the City Council of New Orleans to levy and collect a parcel fee of up to \$650.00 on all taxable parcels within the boundaries of the Upper Hurstville Security District for seven years; and

Whereas, the Board of Commissioners of the Upper Hurstville Security District requests that the City Council of New Orleans impose, levy and collect a parcel fee of \$395.00 on each taxable parcel within Upper Hurstville, and add such fee to all the property bills to be issued by the City of New Orleans to the owners of the taxable property within the UHSD that are subject to the fee for the tax year commencing 2015; and,

Whereas, in connection with the City Council's collection of aforesaid \$395.00 parcel fee, it being necessary that the Upper Hurstville Board of Commissioners first adopt and plan and a budget of revenue and expenditures for 2015 which indicates how the proceeds of the aforesaid \$395.00 parcel fee will be expended for the purpose of providing for an increase in the presence of security enforcement personal;

Now Therefore,

Be it resolved that the Upper Hurstville Board of Commissioners submit the following plan and budget of revenue and expenditures for 2015 which indicates how the proceeds for the aforesaid \$395.00 parcel fee will be expended for the purpose of providing for an increase in the presence of security enforcement personal, be and the same is adopted.

UPPER HURSTVILLE SECURITY DISTRICT PLAN AND BUDGET OF REVENUE AND EXPENDITURES FOR 2015

PLAN FOR 2015

In 2015, the Upper Hurstville Security District (the "UHSD") will provide security patrols and other services permitted by La. R.S. art. 33:9091.6. That legislation authorized the New Orleans City Council of New Orleans to impose and collect a parcel fee not to exceed \$650 a year on each of the parcels of ground located in the district.

The UHSD anticipates that the provision of the services permitted by the above referenced legislation will cost \$192,250. On September 2, 2014, the majority of the UHSD Board of Commissioners resolved that the yearly parcel fee be set at \$395.00 for 2015. This resolution is recorded in the official minutes of the UHSD Board meeting minutes of September 2, 2014.

BUDGET FOR 2015

On September 2, 2014, the UHSD Board resolved to adopt the following budget of revenue and expenditures for 2015 which indicate how the proceeds of the aforesaid \$395.00 parcel fee will be expended for the purposes permitted by the Act. This budget includes ancillary administrative and support services necessary to facilitate the security services provided.
