

SECURITY CAMERA ARRANGEMENT – NEW CAMERAS AFTER JANUARY 1, 2019

The Upper Hurstville Security District (UHSD) appreciates the assistance of the property owner (Owner) named below in arranging for the monitoring of a security camera or cameras in UHSD at the Owner's home or other property. This memorandum sets out the mutual understanding of UHSD and the property owner for incorporation of the Owner's camera(s) into the UHSD Camera System (the System); and for access by UHSD from Owner to footage of the camera(s) along with other camera(s) in the UHSD on such a basis as UHSD deems appropriate.

In exchange, for a limited time, UHSD is willing to reimburse Owners 50% of the cost incurred in purchasing, installing, and monitoring a Ring Doorbell Camera or Camera w/Lights system at a suitable location on Owner's property up to a **maximum of \$200**. A suitable location will be one viewing the street or driveway, and with a connection to electricity (if needed) and to a WIFI source provided by the Owner. Owner acknowledges that camera(s) located within the Security District and made part of the System are intended to serve not only the immediate vicinity of the Owner's home or business but also the security needs of the entire Security District. All too often, it may be your neighbor's camera that provides the definitive footage of a crime committed on your property. Owner agrees to provide evidence to UHSD of the locations chosen by Owner.

If a crime is committed within the confines of UHSD, and if your camera is part of the System, a representative of UHSD may ask for you to research and provide footage in the event you uncover evidence of a crime within the District. Owner agrees to take good care of the cameras, to maintain vigilance over the functionality of the camera from time to time, and to provide electricity and maintain a connection with the WIFI connection mentioned above on a continuous basis. Evidence of an Owners' purchase of the Ring cameras (www.ring.com) and/or lights and a signed copy of this agreement can be provided by email to info@upperhurstville.com or in paper form to any UHSD Board Member.

Additionally, upon Owner's discovery of the occurrence of any crime against a person (robbery, assault, battery, etc.) or any crime involving a significant theft or a burglary to a home, shed or a vehicle, etc. located within the District, Owner agrees to file a New Orleans Police Department report documenting such event and the approximate time it occurred and to report such occurrence to UHSD by email to the above email or to a UHSD Board Member. Further, Owner agrees to make a reasonable review of its cameras footage and to provide pertinent footage to info@upperhurstville.com and to law enforcement, if asked. The importance of pinpointing as closely as possible the exact time of the crime cannot be overestimated due to the laborious nature of reviewing camera footage. Further, although the Ring Systems are self-intuitive and very easy to install and set up, if an Owner needs help in setting up its Ring System, UHSD agrees to assist in the installation insofar as is practicable. Either party may cancel this Arrangement with prior written notice to the other. This one year term will automatically renew each successive calendar year unless cancelled by UHSD or the Owner prior to January 1st of the year following the year in which this Arrangement is executed.

The property owner understands and agrees that designated, approved members of the UHSD board, UHSD's security contractor, or law enforcement personnel may request camera footage as needed and Owner agrees to make a good faith effort to provide appropriate footage clips by email to a designated email address or to info@upperhurstville.com. Cameras purchased on or after January 1, 2019 qualify for this offer. This offer is for a limited time only and subject to prior withdrawal without notice.
